**To be eligible for the contest, the students must:**

- ✓ Be a high school junior or senior.
- ✓ Be a dependent of an active Lea County Electric Cooperative (LCEC) member and reside in the LCEC service territory.
- ✓ Submit the completed application and three (3) written short essays to LCEC by the close of business (5:00 p.m.) on Friday, October 6, 2023.

## **APPLICATION PROCEDURE**

**Applications will be considered when the following information has been received at Lea County Electric:**

1. Completed application with applicant's and parent/guardian's signatures.
2. Parent or guardian's current LCEC account number provided on the application. (The account number will be printed on member's most recent billing).
3. Three (3) completed short essays written on the suggested topics. Two (2) essays are chosen by LCEC and are not limited to the number of words included. One (1) essay is the applicant's choice from four (4) suggested topics and is limited to 500 words.

Selection will be made without regard to the applicant's race, color, ethnicity, religion, gender, or physical handicap. Winners from LCEC will be selected for the Washington, D.C. trip. Selection is based on the completed application. The 2024 Government-In-Action Youth Tour will be held June 17-22. Delegates selected to represent LCEC as a Youth Tour delegate are required to travel with their state delegation for the full tour. Delegates are not allowed to travel independently from the delegation to, from or during the trip to Washington, D.C. except in the case of an emergency. In the event of an emergency, arrangements must be approved and will be coordinated through the Statewide organization. If a delegate cannot attend the entire Youth Tour, the delegate will be required to forfeit the trip and will become an alternate.
