#### Equipment needs for transporting grill/trailer (weighs 7600 lbs):

• Recommend: 3/4 ton pickup (adequate brakes- electric brake controllers) 2 5/16" ball hitch
Lights hookup

#### Territory for usage grill/trailer by member

- Grill/trailer is for use in the Lea County Electric service territory unless otherwise approved by General Manager. A time frame for return must be designated and recorded on appropriate form at time of issue.
- CDL license required in Texas if complete rig weighs over 10,000 lbs.

#### **Training**

- Each member/user shall be responsible for reviewing rules for transporting and using the grill/trailer upon pickup of equipment at the plant.
- Equipment is not to be altered in any way including propane bottles and is to be returned in good condition.
